SSAE 16 is the authoritative guidance that allows service organizations, such as cloud computing providers, to disclose their control activities and processes to their customers and their customers' auditors in a uniform reporting format. The SSAE 16 report includes comprehensive reviews and tests of Digitech Systems general computer controls. Federal regulations such as Sarbanes-Oxley, Gramm-Leach-Bliley and the Health Insurance Portability and Accountability Act (HIPAA) require corporations to audit the internal controls of their suppliers, including those that provide cloud services. By undergoing the SSAE 16 audit, Digitech Systems can provide its customers with a comprehensive audit report that facilitates compliance with these and other regulations.
